Itinerary Notes

CHECK-IN For all flights the group is requested arrive at the airport a minimum of 2 hours before departure

Increasing traffic congestion is a reality in many urban centers and our itineraries are designed so travel/transit times take

that into consideration. However, traffic is the number one reason for a delay while on tour and we ask that educators/organizers remain flexible as the itinerary may have to be modified while on tour should a delay occur.

Electronic Logbooks and Motorcoaches

In the next few years and even months new regulations regarding motorcoach safety will be coming online. Most motorcoach companies will be required to have Electronic Logging Devices (ELDs) to track service and driving hours of the motorcoach operator/driver. FMCSA rules are for the operator to be in service for a maximum of 15 hours and cannot drive for over 10 hours and must get 8 hours consecutive hours off for rest.

GO Educational Tours primary focus is on student and passenger safety and our itineraries have always respected these rules. As ELDs come online there will be more scrutiny of the drivers and except for very exceptional circumstances no motorcoach operator will derogate from these rules.

Our itineraries will continue to be structured to respect all FMCSA rules.

American Bus Association Memo

The Federal Motor Carrier Safety Administration (FMCSA) has announced that it has amended the Federal Motor Carrier Safety Regulations (FMCSRs). These new regulations will establish minimum performance and design standards for hours-of-service (HOS) electronic logging devices (ELDs); require the mandatory use of these ELDs by all commercial motor vehicle drivers currently required to prepare HOS records of duty status (RODS) requirements concerning HOS supporting documents; and address concerns about potential driver harassment resulting from the mandatory use of ELDs.
